Vacancy notice No. Admin/Rec./PWD/SN-II/2015-AIIMS.RPR dated 02.12.2015 was issued for filling up the post of Staff Nurse Gr.II (PWD-OL) on direct recruitment basis. The details are as under :-

2. It was clearly mentioned in the call letters issued to the candidates that the final selection for the above posts will be made on the basis of marks scored in the written examination subject to their fulfilling all the eligibility criteria for the respective posts.

3. Accordingly, candidates who have appeared in the written examination were called for document verification. Out of these, 12 candidates appeared for document verification. **Only those candidates who appeared for document verification have been considered for Selection and Final Select list has been prepared on the basis of marks obtained by such candidates in the written examination subject to their fulfilling all the other eligibility criteria. The category wise cutoff marks out of maximum 100 were kept as under :-**

UR category : 33% marks in written exam

OBC category : 30% marks in written exam

SC /ST category : 27% marks in written exam

No candidate is found suitable for ST vacancy as only 01 ST candidate has appeared in the written examination and she has qualified at UR standard.

4. Candidates should note that their selection is subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS, Raipur if at any stage of their appointment it is found that he/she does not fulfill any of the eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the post.

5. Candidates belonging to reserved categories meeting the UR standards i.e. cutoff marks for UR category and age limit, have been selected against the UR vacancy.
6. It is important to note that some of the candidates have been declared qualified only for the category mentioned against their Roll Number. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is therefore, in the interest of the candidates concerned to immediately contact AIIMS, Raipur in all such cases where they do not belong to the category shown against their Roll Numbers.
7. Offer of appointment to selected candidates shall be issued shortly.
