## Item Name: Single Blood Bags (350 ml)

1. Single Blood Bags 350 ml capacity, with sharp needle-16g.It should have CPDA-A as anticoagulant. The composition of anticoagulant should be as follows:

Trisodium citrate

Citric acid (monophydrate)

Sod. Dihydrogen phosphate

Dextrose (monohydrate)

Adenine

Distilled water

- 2. Dual packaging (individual and aluminium) eliminating microbial contamination on surface maintaining the contents of the bag.
- 3. Blood collection Bag made up of DEHP plasticized PVC non-vented sterile containers complete with collecting tube for completely closed system to avoid the chances of contamination.
- 4. Double sterile, pyrogen free transparent, leak proof PVC/Non PVC bags. Should confirm to ISO 3826 for container

#### **Outlet Port Pouch**

- 5. Each outlet port is fitted with a hermetically sealed tamper evident protector to maintain sterility of the internal surface
- 6. Can be opened with single-handed operation.

## Pre-donation bag (PDB)

• Diverts 5-10 ml of initial Blood

### **Needle**

- 7. Ultra-thin walled silicone coated 16G venipuncture needle with bevel guard as per ISO 1153-3 standard with authentication certificate
- 8. High quality needle for smooth phlebotomy
- 9. Minimal stress to the donor
- 10. Motivates voluntary blood donation
- 11. Safe and easy to open temper evident outlet port, which should not recapped.
- 12. Labels having mfg. date, exp. Date and Batch No.
- 13. High quality peel resistant label.
- 14. Sample collection Pouch should be present with the bag/or without sample collection.
- 15. Proof of compliance with ISO 3826 & ISO 1135.3 should be submitted by the company.
