Terms & Conditions:

- Preparation and Submission of Tender : The tender should be submitted in two parts i.e. Technical Bid and Financial Bid. The Technical Bid and the Financial Bid should be sealed by the bidder in two separate covers "Technical Bid for Supply of CCTV" and "Financial Bid for Supply of CCTV". Both Sealed Envelopes should be kept in a main/ bigger envelope super-scribed as "Tender for Supply of CCTV".
- 2. Earnest Money Deposit: The bidder shall be required to submit refundable amount of ₹ 30,000/-(Rupees Thirty Thousand only) as Earnest Money Deposit (EMD) and a non-refundable tender fee for an amount of 1,000/-(Rupees One Thousand only) by way of demand drafts only. The demand drafts shall be drawn in favour of "All India Institute of Medical Sciences, Raipur" payable at Raipur. The demand drafts for earnest money deposit must be enclosed in the envelope containing the technical bid.

The EMD of the successful bidder shall be returned after the successful completion of contract / order and for unsuccessful bidder(s) it would be returned after award of the contract. Bid(s) received without demand draft of EMD / Tender Fees will be rejected.

- 3. **Rate:** Rate should be quoted in Indian Rupees (INR) on **DOOR Delivery Basis** at AIIMS, Raipur, Chhattisgarh, Inclusive of all the Charges, with break-ups as:
 - Basic Cost.
 - VAT /CST as applicable.
 - Total Cost (F.O.R at AIIMS Raipur).
- 4. **Validity:** The quoted rates must be valid for a period for 120 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender.
