Terms and conditions for licensing out built up **Canteen, L G F, Trauma Block**, AIIMS RAIPUR,

TERMS AND CONDITIONS FOR TENDER

1. Tender must be submitted in two sealed envelopes separately i.e., the tender form duly signed on every page along with all the required documents in one envelope (**Envelope-A**) and only the offer/price bid on the prescribed Performa (**Annexure-II**) in the second envelope (**Envelope-B**). Both the envelopes are to be sealed in Master envelope. Those who fail to follow this procedure may be disqualified forthwith.

EARNEST MONEY

2. Tender must be accompanied with Earnest Money Deposit (EMD) amounting to **Rs.1,35,000/-** in the shape of Pay Order or Banker Cheque or Demand Draft, from any scheduled bank at Chhattisgarh in favour of the , AIIMS Raipur. No other format for Earnest Money deposit would be accepted.

RECEIPT & OPENING OF TENDERS

3. Tender should reach in the office of The A.O., AIIMS Raipur upto **08-10-2013** on or before **03:00 P.M.** Tender document/technical bid shall be opened on **08-10-2013** at **03:30 P.M.** (in the presence of tenderers or their authorized representative) In case, the last date of receipt of tenders happens to be a holiday/bank holiday in Chhattisgarh, the tenders will be received till the next working day upto the same time.
4. Earnest Money/Security Deposit and pre-qualification documents etc., already deposited with the Institute in connection with any other case/tender shall not be considered.

PRE-QUALIFICATION DOCUMENTS

5. The following pre-qualification documents are to be submitted along with the tender form in a separate envelope from the envelope containing the commercial bid. However, the tenders received without any of the following documents, may render the tender invalid and the commercial bid would not be opened: -
 - a) The applicant must be resident of India and one of the following documents (duly attested) mentioned will be submitted as a proof of residence namely: -
 - (i) Passport.
 - (ii) Ration Card
 - (iii) Driving Licence
 - (iv) Water/Electricity bill (Latest)
 - (v) Voter Identity Card
 - (vi) Telephone Bill.
 - (vii) Smart Card
 - (viii) Adhar Card
 - b) Attested photocopy of the Ownership Document, in case of firm a Partnership Deed and Registration Certificate under Companies Act along with memorandum of association etc. as the case may be.
 - c) In case of firm/company, an Attested photocopy of authority to negotiate and sign tender and licence deed on behalf of the firm/company.

- d) The tenderer applying for Cafeteria/Canteen/Restaurant/Mess should have experience of **minimum two years** of providing similar services with cooking facility (Experience of running snack bar will not be considered).
 - e) Two Passport size photographs duly attested by the Gazetted Officer/Notary.
 - f) A Passport size photographs duly attested by the Gazetted Officer should be pasted on the tender form at last page.
 - g) Affidavit to the effect that the firm/individual is not blacklisted by any Govt. Organisation and that no criminal case is pending against him/his partner (Annexure-III).
 - h) The tenderer should have licence from the competent authority under the prevention of Food Adulteration Act/rules during the past five years. Attested copy of the same should be enclosed with the tender form.
 - i) PAN Number and photocopy of PAN Number duly attested.
 - j) The tenderer would be required to take licence from the competent authority under the prevention of Food Adulteration Act/rules from, Health Department, Chhattisgarh within one month of taking over the possession.
6. If more than one tender is received from one/ single firm or its partners or director of the company the tender with the highest bid from the said firm will be entertained.

IMPORTANT NOTE:-

- (i) Price bid once submitted with tender cannot be revised (unless or otherwise negotiated after opening of tender/bid).
- (ii) The person who backs out after bidding will be debarred for next three years from dealing with the AIIMS, RAIPUR. His/her earnest money shall also be forfeited.
- (iii) The tenderers will be responsible for submitting medical examination report of all the food handlers engaged at the premises within one month of taking over the site and then every six months.

OTHER CONDITIONS REGARDING ALLOTMENT OF SHOP

7. Though the licensee/firm either himself / herself or through any partner / close relation i.e., son/daughter/father/mother can have concurrent licence of only one shop at a time from the AIIMS, RAIPUR for running the trade mentioned in this tender, however, an existing licensee may apply for the shop/trade tendered subject to the following conditions: -
- a) He/she/they will have to surrender the exiting shop as per terms & conditions of licence before accepting the offer for the new shop of similar trade and will have to hand over the vacant possession of the existing shop before taking over the possession of the new shop.
 - b) The existing licensee will given vacation notice as per terms and conditions of licence and will have to pay the licence fee which may fall short of 60 days mandatory notice period.
- Note:** A Licensee cannot have more than one licence of the shop of similar trade from AIIMS RAIPUR and in case at any stage it is found that he/she or through any partner/close relations i.e. son/daughter/father/mother has any interest/share/partnership in any other shop of the similar trade, the licence shall stand terminated/cancelled & his/her/their security forfeited.
8. The licence will be given for **three years** which is awardable in order of highest bid and shall be governed by the provisions of the Public Premises (Eviction/Regulations) Act and rules framed there under from time to time for the purpose of any action in case of default. In case the first highest bidder backs out and fails to take possession of the premises he/she will be debarred for three years and the earnest money shall be forfeited and the next two tenderer(s) in order of licence fee rates/bids may be considered for/offer the license as per direction of the Authority. If, the next two tenderer(s) also back(s) out and fail(s) to take possession of the premises, their earnest money shall also be forfeited, debarred for next two years, the tender may be cancelled and the fresh tender will be floated.
9. The Director, AIIMS RAIPUR, reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever, and without any prior notice to the tenderers whatsoever.
10. The rates should be mentioned both in figures as well as in words in price bid
Annexure-II.

DOCUMENTS/PAYMENTS TO BE SUBMITTED BY SUCCESSFUL TENDERER (S)

11. (i) Documents/payments are to be submitted/deposited by the successful bidder within 15 days from the issue of licence memo or before taking over the possession of the premise whichever is earlier. The possession of the premises will be given after the submission of the following documents: -
- a) Licence Deed on Non-Judicial Stamp Papers Worth Rs.5/-.
 - b) One-Month Advance Licence Fee with service tax.
 - c) Security deposit equal to the amount/sum of three months Licence Fee plus Service Tax.
 - d) Latest Police Verification report from the concerned police authorities to the effect that there is no criminal case pending in any Court of law against the applicant/Firm.
- (ii) In addition to above, the successful bidder shall submit a Bank Guarantee or Fixed Deposit (FDR) pledged in favour of AIIMS, RAIPUR, issued by any local nationalized bank, equal to 3 months licence fee as security which shall remain valid upto one month after the expiry of the licence period, within a month of taking over possession. Failure to submit the Bank Guarantee/pledged FDR in time shall attract a fine of **Rs.2500/-** per day and if delay is more than 15 days, the offer of licence is liable to be terminated.
- Note:** If the licensee does not submit the aforesaid documents/payments within the stipulated period a fine @ **Rs.500/-** per day will be charged for each day of delay beyond the stipulated period, till the actual deposit of the same. In this case allotment is also liable to be cancelled; EMD forfeited and offer may be made to the 2nd or 3rd highest bidder as per the decision of the licensor.*
12. The tenderer will be sole proprietor of the premises, and if not, the document-governing letter of Authority from the firm shall be furnished along with the documents mentioned in the para-12 above.

PERIOD OF LICENCE

13. The licence shall initially be for a period of **three year**(*subject to satisfactory services*) with 10% increase every year in the licence fee for the second year onwards. The licence is extendable by the AIIMS, RAIPUR subject to the satisfactory service of the licensee and may be extended entirely on the discretion of the Director, AIIMS RAIPUR, for terms and increase in monthly licence fee for each term as deemed fit by the authorities. The licensee shall not be eligible for such extension as a matter of right whatsoever, and the decision of the Director, AIIMS RAIPUR, shall be final and binding on the licensee. In default the provisions of P.P. Act, 1971 shall be invoked.

POSSESSION OF THE PREMISES

14. Failure to occupy the premises within 15 days of issue of acceptance/licence letter may result in forfeiture of earnest money and cancellation of licence. In case the licensee, after acceptance of letter of licence of the premises, fails to furnish all the required documents and/or take possession of the said premises within 15 days from the date of issue of letter of licence, he shall be charged licence fee at the rates quoted by him from such date upto the period/date, alternative arrangements for running the said premises are made by the Institute.
15. For the purpose of trade, the licensee at his own cost shall ensure display of approved/fixed rates and discount to be charged by him from the customers and other relevant terms and conditions. He shall not charge in excess of the rates.

The licensee shall use the premises solely for the purpose for which it has been licensed out, and for not other purpose and he shall not part with the premises/sublet the premises to any one directly or indirectly.

16. a) The licensee will sell items listed in **Annexure-I & II** only. The licensee will be required to strictly adhere to the specification / scale / quality / quantity / brand of various items as mentioned in **annexure-I & II**. He shall not charge in excess of the approved rates, as mentioned in **Annexure-I** and as approved for **annexure-II**.

b) The licensee shall ensure provision and sale of quality products, and in no case the items as above which are spurious soiled, damaged, post-dated and expire would be stocked or sold by the licensee. Breach of these conditions will entail immediate suspension and cancellation of the license. The products shall conform to the rules and laws of the Govt. regarding their sale.

PAYMENT OF LICENCE FEE

17. The licensee shall pay to the licensor monthly licence fee in advance and without demand by 7th of each month along with Service Tax or any other tax/Cess imposed or revised by the competent authority from time to time. The licence fee for the first month shall be paid within 15 days from the issue of letter / memo. of licensing out of the said space and before taking possession. In case of failure to pay, licence is liable to be withdrawn. The licensee shall pay interest @18% p.a. on licence fee due from him, if he/she does not pay the same on due date, but will not be permitted to do so beyond one month and thereafter his licence is liable to be cancelled and the security forfeited.
18. The licensee will deposit licence fee in cash or by crossed Bank Draft of any scheduled bank at in favour of AIIMS, Raipur, Chhattisgarh.

PAYMENT OF ELECTRICITY/WATER CHARGES

19. In addition to the licence fee the licensee shall pay the bills of electricity/water according to the reading of electricity/water meter to be installed by him at his own cost and the arrears, if any will be recovered from the security. In case separate electricity/water meter is not installed, the licensee shall pay the charges of electricity/water at flat rates fixed by the Superintending Engineer, AIIMS, RAIPUR, Chhattisgarh from time to time. The licensee will pay the electricity/water bills raised by the Institute within 10 days from the issue of bill failing which the electricity/water supply will be disconnected without any intimation and the arrears if any will be adjusted from the amount of security deposit.

SECURITY DEPOSIT

20. For the faithful performance and observance of the terms and conditions of the licence, the licensee shall deposit in advance within 15 days from the issue of letter/memo. of the offer of the licence and before taking possession of the said premises, security deposit equal to amount/sum of three months licence fee plus service tax with the Director, AIIMS Raipur, which will be kept by the Institute and refunded only after completion of the tenure.
21. The licensee will deposit the amount of security in cash/in shape of FDR or by crossed Bank Draft (of any scheduled bank at Raipur), in favour of AIIMS Raipur.
22. The security or remainder thereof, if not forfeited shall be refunded to the licensee after the expiry of the licence, after the vacation of the premises by the licensee and after adjusting dues, if any.

BANK GUARANTEE / PLEDGED FDR

23. In addition to the above, the licensee will give within one month of taking over the possession, a Bank Guarantee or Fixed Deposit (FDR) pledged in favour of AIIMS RAIPUR issued by any local nationalized bank, of an amount equal to **3 (three)** months licence fee, as performance guarantee, as per the conditions mentioned in the paras above, which shall remain valid till one month after the expiry of licence period. Non- submissions of bank guarantee/pledged FDR within one month of taking over the possession shall attract penalty of **Rs.2500/- per day** and if the delay is more than 15 days the license is liable to be terminated. **The licensee will give pledged FDR from his / her own bank account /firm account and pledged FDR from the account of third party / any other person / firm shall not be considered.**

EMD of the allottee/licensee will be refunded only after submission of the bank guarantee/ Pledged FDR and in case of non-submission of bank guarantee, the same will be kept as security till submission of the bank guarantee/pledged FDR and may be adjusted against dues, if any. However, in case the allottee/licensee without submitting the bank guarantee/ pledged FDR, terminate or submits vacation/termination notice before expiry of one month from the date of possession, his/her EMD shall be forfeited.

24. In the event of breach or non-observance of any of terms and conditions of this licence, the Director may forfeit the Security either in full or in part and in that case the bank guarantee/pledged FDR may also be encashed, if required.

LICENCE DEED

25. The licensee shall execute necessary licence deed specifying the terms and conditions as mentioned herein, on the Non-judicial stamp papers worth Rs.5/- at his own cost, within 15 days from the issue of licence memo, along with other documents/ payments, failing penalty as mentioned above shall be imposed.

SPECIFIC CONDITIONS

26. *The successful tenderer would be required to take licence from the competent authority under the prevention of Food Adulteration Act/rules from the, Health Department, Chhattisgarh **within one month of taking over the possession**, and submit a copy of the same with the Administrative Officer (within one month of taking over possession) failing the licence may be terminated.*

27. **Use of LPG and safety measures:**

- a) *The tenderer/licensee will not keep LPG cylinder in the allotted premises /kitchen. They must fabricate a manifold outside the building/ shop and the supply of the LPG should be through pipeline only. The licensees will fabricate the manifold and the LPG supply pipe line (ISI) at their own cost **within 15 days of taking over the possession of the premises.***
- b) *The licensee should use only **commercial LPG cylinders.***
- c) *Licensee should not keep LPG cylinder and should not use LPG stove in the premises/kitchen. In case violation, cylinder will be confiscated.*
- d) *The licensee must keep adequate number of fire extinguishers in the shop (in consultation with the Fire Officer, AIIMS, RAIPUR) **within 15 days** of taking over possession.*

MAINTENANCE OF THE PREMISES

28. (a) The licensee shall keep the premises in a clean sanitary and tenable condition and shall pay for the cost of making good any damage thereto or to adjacent premises, caused by negligence or misuse of premises by the licensee or before taking over possession whichever is earlier and shall indemnify the licensor against any loss/damage/ additions/ alterations to the premises. **The licensee will get the whitewash / paint done in the shop at his / her own costs from time to time as & when required.**
- (b) The licensee shall not store empty packing cases or baskets or any goods or any other material on the open spaces around the premises or any other place from where such goods or material may be visible from outside. The area in front of the said premises shall not be encroached upon and used or allowed to be encroached upon or used for any purpose other

than the public passage. **The licensee shall not make any addition or alternation in or around the premises without the written consent of the Director, AIIMS, RAIPUR, Chhattisgarh.**

- (c) The licensee would provide dust free, mosquito, cockroach and fly free environment. The conditions, which increase the infection, shall not be allowed. The licensor reserves the right to issue directions from time to time for proper sanitation and cleanliness of the premises. These will have to be followed by the licensee.
- (d) In case of failure to implement the directions regarding condition and sale of the products and maintenance of the premises, **a fine to the tune of 2%, 5% and 10% for the monthly licence fee be imposed upon the licensee for 1st, 2nd and 3rd violations respectively. However, the discretion to impose the minimum fine upon the shops/sites lies with the DDA of AIIMS RAIPUR**, his tender is also liable to be terminated by the Director, AIIMS, RAIPUR. The decision of the Director, AIIMS, RAIPUR, Chhattisgarh, in this case shall be final and binding.
- (e) The licensee will not sell items at higher rates than the MRP or prevailing market rates and shall give mandatory discount, failing suitable penalty/fine will be imposed for every laps by the Director, AIIMS, RAIPUR. The licensee will stock / sell only quality / branded products as mentioned in Annexure-II. **Use of cups/glasses of plastic material will not be allowed** failing suitable penalty/fine will be imposed for every laps by the Director, AIIMS, RAIPUR.
- (f) The penalty fine so imposed for violation must be deposited within stipulated period failing interest @ 12% will be charged.
- (g) The licensee would install an Air-conditioner of a reputed company at his own cost and will pay the electricity charges to the Institute.
- (h) The licensee will install Water Purifier of a reputed brand and Aqua guard (Eureka Forbes) etc., as to provide purified drinking water.
- (i) The rates should be displayed prominently in the premises of the shops.
- (j) The licensee will also renovate the furniture and floor area for the convenience of the Doctors.
- k) All the food items as per list should be available in sufficient quantity all the time.
- l) The licensee will not keep any display counter / equipment etc. in the 'Veranda' or open space in front of or around the shop allotted failing necessary action will be taken / penalty imposed.
29. The licensee shall ensure promptness of service at the counter and shall appoint necessary staff for the purpose and shall also ensure that there is no mismanagement on his part or his agents and servants. In case of failure, to implement the directions regarding service at the counter, suitable fine may be imposed by the Director, AIIMS, RAIPUR, Chhattisgarh and his licence is also liable to be terminated by the Director, AIIMS, RAIPUR.
30. The licensee shall not use any electric broadcaster or any other article that may disturb the atmosphere of the Hospital.
31. (a) The licensee shall pay during the terms of licence all the Central/local taxes and cesses for the time being imposed or assessed on the premises by the competent authority from time to time.
- (b) The licensee shall pay service tax on the licence fee as notified by the Central Excise Commissionerate from time to time. The Service Tax should be deposited along with monthly licence fee.
32. a) No obnoxious trade like Bidi, Cigarette, Pan Masala etc., shall be carried on at the premises. The licensee shall ensure strict 'NO SMOKING' inside the premises.
- b) Sale/stock of Bubble Gum/Chewing-gum and spitting is banned in the Institute premises. Hence, the licensee will not stock/sell Bubble Gum/Chewing-gum or toffees with gum ingredients at the shop/site, failing suitable penalty will be imposed.
33. a) The licensee will maintain cleanliness and hygienic condition in the kitchen and dining area of the mess. He will also be required to get the kitchen white washed from time to time. He will employ sweepers & arrange cleaning material and spray of insecticides at his own cost.
- b) The licensee will ensure that the employees engaged by him should not carry any communicable disease. They will maintain personal hygiene and cleanliness. They should wear aprons, caps and gloves while preparing / serving food. The licensee will also verify and inform

their identity to the police post, AIIMS, RAIPUR and will be responsible for all the acts and omissions of its employees.

34. a) The licensee would be required to get license under the Prevention of Food Adulteration rules from the, Health Department, Chhattisgarh (wherever required / necessary).
- b) The licensee shall not employ any child labour(s) in contravention of the LABOUR EMPLOYMENT ACT, 1970.
- c) The licensee will be fully responsible for implementation of Labour Laws/ Shops & Establishment Legislation including minimum wages, ESI, E.P.F., Workmen Compensation etc.
35. The licensee will provide services in the Canteen to the Patients & officers of AIIMS, RAIPUR only.
36. The licensee would be required to make necessary fire safety arrangement in the Canteen and also install appropriate number of fire extinguishers in consultation with the Fire Officer of AIIMS, RAIPUR to ensure safety and security of the public, self and the Institutes property.
37. Neither this licence nor any of the rights conferred by it shall be transferred or assigned to any other person, nor shall the premises or any part thereof be sublet directly or indirectly.

VACATION / TERMINATION NOTICE

38. Notwithstanding anything contained in condition 14 above, the licensor shall be at liberty to terminate this licence by giving 30 days clear notice ending with the expiry of that month of licence without assigning any reason whatsoever. However, the licensee may terminate this licence by giving 60 days clear notice ending with the expiry of the month of licence. In this case he/she will be debarred for participating in this tender process initiated for allotment of the same shop/site subsequent to his/her vacation notice and 50% of the one month licence fee will be charged/deducted from the licensee and the same will be deducted from his security deposit subject to minimum of Rs. 20,000/- and maximum of Rs. 5 lacs(including the cost of re- tendering).

However, the Director, AIIMS, RAIPUR reserves the right to allot the licence to the 2nd or 3rd highest bidder, in case the initial licensee opts to terminate the licence any time during the period of initial allotment of the licence.

BUSINESS TIMINGS OF THE PREMISES

39. The timings of the said premises for providing services shall be **round the clock**. The presence of licensee or his authorised persons shall be ensured during the said working hours, otherwise it would be a violation of the terms and conditions calling for termination of licence followed by eviction.

ARBITRATION

40. Any dispute arising out of this contract at any stage shall be referred to the Director, AIIMS Raipur whose decision shall be final and binding upon both the parties.

VACATION OF THE PREMISES AFTER EXPIRY/REVOCAION OF LICENCE

41. The licensee shall deliver the vacant possession of the premises to the Director, AIIMS, RAIPUR after the expiry or revocation of the licence. In case, the licensee fails to handover the vacant possession after expiry of licence period, he will be liable to pay 5 times of monthly licence fee after the licence period has expired unless it is extended by the Director, AIIMS, RAIPUR, Chhattisgarh. In case of non-deposit of the fine as above, the same is liable to be deducted from the security deposit/bank guarantee/pledged FDR. In such case the licensee shall be governed by the provisions of P.P. Act, 1971.
42. The licensee shall permit access to the Director, or his duly authorised agent or servant at all reasonable times for the purpose of inspecting the premises and the trade or business carried therein.
43. The Director, AIIMS RAIPUR, may modify, impose or relax any clause in the terms and conditions. Power to terminate the licence will lie with the DAIIMS, RAIPUR whose decision will be final and binding.
44. In case of breach of any of the terms and conditions of this licence, the Director, AIIMS, RAIPUR may revoke this licence and forfeit the security/EMD and the licensee shall thereupon forfeit all the

rights hereunder, and shall remain liable for any sum then due, from him and also for any damage or loss which may be caused to the licensor by reason of such default or for making any alternative arrangement for running the said premises.
