2. It was clearly mentioned in the call letters issued to the candidates that the final selection for the above posts will be made on the basis of marks scored in the written examination subject to their fulfilling all the eligibility criteria for the respective posts.

Accordingly, the Competent Authority in AIIMS Raipur has decided the following qualifying criteria:-

For UR category :- 40% marks in the written exam.
OBC category :- 35 % marks in the written exam.
SC/ST category :- 30% marks in the written exam.

3. On the basis of the marks obtained by the candidates in the written examination and the short listing criteria fixed by the Competent Authority in AIIMS, Raipur, candidates were shortlisted and called for document verification from 28.09.2016 to 08.10.2016.

4. Only those candidates who appeared for document verification between the specified dates have been considered for selection and Final Select list has been prepared on the basis of marks obtained by such candidates in the written examination subject to their fulfilling all the other eligibility criteria.
