Sealed tenders will be received till 06-05-2016 up to 03:00 PM in office of Store Officer for **TENDER FOR RATE CONTRACT OF DRUGS AND MEDICINES FOR IPD FOR 1 YEAR** from the date of acceptance of tender by AIIMS, RAIPUR. The tender may be extended for further period of 6 months on mutually agreed terms. Demand Draft/Pay Order for Rs.5700/-(Rupees Five Thousand Seven Hundred Only) including VAT (non-refundable) in favour of "AIIMS, Raipur", payable at Raipur, against cost of the tender document along with their technical bid. If firm will quote the rate for **1 to 10** items, **11 to 50** and **more than 50** items, The Earnest Money Deposit (EMD) shall be ₹20,000/-(Rupees Twenty Thousand only), ₹30,000/- (Rupees Thirty Thousand only) & ₹1,00,000/- (Rupees One Lac only) respectively paid in the form of Demand Draft/Pay order/ Bank guarantee / FD any scheduled bank drawn in favour of A I I M S , Raipur payable at Raipur. The EMD amount of unsuccessful bidder will be refunded to them within 45 days of finalization of tender. In respect of successful bidder, the EMD amount will be return to after successfully submission of security deposit.

Bidder may quote for molecules of one or more than one manufacturer with valid Authorization letter. EMD will be considered for cumulative No. of molecules Quoted by bidder whether it is of one manufacturer/ importer or more than one manufacturer/importer. Authorized dealer/distributor/wholesaler/manufacturer (Loan License, third party and Contract manufacturer) /importer can be eligible to participate in this tender.

The license must have been duly renewed up to date and the items quoted shall be clearly highlighted in the license. Items for which FDA do not issue manufacturing license but issue repacking license, firm should submit valid repacking license. If revalidation of drug license has been applied, copy of application to State Drug / Licensing authority may be attached.
- b) The manufacturer should have received a valid cGMP as per WHO-GMP inspection certificate in line with the WHO certification scheme, on pharmaceuticals being quoted. Bidder should submit a valid product wise Certificate of GMP as per WHO-GMP issued by Regulatory Authority, for each item offered. License no. and manufacturing unit address clearly highlighted on GMP certificate.
- c) Manufacturer should at least have 3 year market standing certificate issued by Regulatory Authority for each drug product quoted.
- d) Annual turnover should have 60 crore in last 3 year (any one year in last 3 year).
- e) A certificate issued by the Licensing Authority that the Manufacturer is not currently under conviction (Non-conviction) under the Drugs & Cosmetics Act for manufacturing/supplying sub-standard drugs or on any other grounds. The certificate should not be more than six month old on the day of opening of the tender.
- f) Tender should not be submitted for the products for which the concern manufacturer has been blacklisted on quality grounds by any Government organization.
- g) The bidder should submit a self-attested affidavit stating that the manufacturing company have not been blacklisted for the quoted product/firm by any State Government or Central Government Organization and has not been found guilty of supplying spurious drugs in last three years and are eligible to participate in the present tender." (Self attested Affidavit as per Annexure III). If the information provided in the affidavit is found to be incorrect at any stage, during and after the tender, action will be initiated as per the tender conditions apart from forfeiture of EMD and performance security deposit (if any).

2. IMPORTER

- a) Importer should having valid License (in Form 10 with Form 41), as per Rule 122A of the Drugs and Cosmetics Act 1940, if the product is imported should be furnished. The license must have been renewed up to date and the items quoted shall be clearly **highlighted** in the license. A copy of a valid license for the sale of Drugs imported by the firms issued by the Licensing Authority shall be enclosed.
 - Form 10-Licence issued for import of drugs except, schedule X.
 - Form 41-Registration certificate issued for import of drugs.
- b) The Importer should have a valid WHO-GMP or Certificate of pharmaceutical product (COPP) issued to manufacturer by Licensing Authority on pharmaceuticals being quoted. Importer should submit a valid product wise Certificate of WHO-GMP or COPP issued by Regulatory Authority, for each item offered. License no. and manufacturing unit address clearly highlighted on GMP/COPP certificate.
- c) A certificate issued by the Licensing Authority that the Importer is not currently under conviction (Non-conviction certificate) under the Drugs & Cosmetics Act for supplying sub-standard drugs or on any other grounds. The certificate should not be more than six month old on the day of opening of the tender.
- d) Importer should at least have 3 year market standing certificate for each drug product quoted in the tender.
- e) Annual turnover should have 60 crore in last 3 year (any one year in last 3 year).
- f) Importer should have Authorization letter issued from Manufacturer of concern drug product.
- g) Tender should not be submitted for the products for which the concern manufacturer / importer has been blacklisted on quality grounds by any Government organization.
- h) The bidder should give a self-attested affidavit stating that Importer has not been blacklisted for the quoted product/firm by any State Government or Central Government Organization and has not been found guilty of supplying spurious drugs in last three years and are eligible to participate in the present tender." PART-II PRICE BID DOCUMENT

PRICE BID (COVER-'B')

(a) **Price Bid** (**Annexure IV**) of the tenderer duly filled in giving the net rate of each items inclusive of all taxes and signed one each page by Authorized person with company seal, should be sent in separate sealed cover indicating name of the tenderer and super scribing "Price Bid" Cover–'B' hereafter called Cover-'B'.

(b) Cover-'B' shall contain the rates quoted by the tenderer only. It shall not contain any other document. No condition shall be indicated in the Price Bid. All the terms and conditions shall be indicated only in the Technical bid.

(c) The acceptable rates for supplied of drugs & medicines will be decided on the basis of lowest rates and will be communicated.

If two or more than two bidders declared as L1 suppliers for the same item of Drugs / Medicines, and such bidders shall execute necessary agreement as specified in the Tender Document on depositing the required amount as Performance Security and on execution of the agreement such bidder is eligible for the placement of Purchase Orders for the item or items of Drugs / Medicines quoted by them. No tenderer will be allowed to withdraw their bid after opening of Price Bid. Enclose Soft Copy of Price Bid (in Excel Sheet) and also password protected PDF (non-editable) in CD. Unique sequence no. of molecule as prescribe in main NIT/ Tender should not be change in any case otherwise that molecule will not be consider for bid competition.



PART-III GENERAL CONDITIONS

GENERAL CONDITIONS

- 1. Forms in all Annexure should be filled up properly. Every correction should invariably be attested by tenderer, failing which the tender will be summarily rejected.
- 2. The tenderer may quote the rates for one or more drug and medicine of one or more manufacturing company for which authorized.
- 3. Total rates should be inclusive of all taxes as per the price bid Performa.
- 4. The rates quoted and accepted will be binding on the tenderer for stipulated period and on account any revision will be entertained till the completion of the contract period.
- 5. The details of the required drugs, medicines etc., are shown in drugs and medicines list. The rates quoted should not vary with the quantum of the order or the destination.
- 6. Tender has been called for in the generic names of drugs. The bidders should quote the rates for the generic products. The composition and strength of each product should be as per details. Any variation, if found, will result into the rejection of the tender.
- 7. Firm should be quoted unit rate with inclusive of taxes for each of the required drugs, medicines etc., separately on door delivery basis (FOR Destination, at Pharmacy store AIIMS, RAIPUR) according to the unit ordered. Tender for the supply of drugs, medicines, etc. with cross conditions like "AT CURRENT MARKET RATES" shall not be accepted. Handling, clearing, transport charges etc., will not be paid. The delivery should be made as stipulated in the purchase order placed with successful bidders.
- 8. The price quoted by the bidders shall not, in any case exceed the controlled price, if any, fixed by the Drug Price Control Order (DPCO)/Central/State Government and the Maximum Retail Price (MRP). Tender Inviting Authority at its discretion, will exercise, the right to revise the price at any stage so as to conform to the controlled price or MRP as the case may be. This discretion will be exercised without prejudice to any other action that may be taken against the bidder at any stage.
- 9. If in any circumstances (like breakdown of instrument or non-availability of stock etc.) the bidder is unable to supply Medicines, the same should be reported within hours and Liquidated damage will be imposed for delay on supply of material.
- 10. To ensure sustained supply without any interruption, the Tender Inviting Authority reserves the right to split orders for supplying the requirements among more than one bidder.
- 11. The rates quoted and accepted will be binding on the bidder for full contract period of 1 years from the date of signing of agreement and extendable period of 6 months by mutual consent with bidder, any increase in price will not be entertained till the completion of contract. Accordingly this clause will be applicable for all orders placed during the currency of contract.
- 12. No bidder shall be allowed at any time on any ground, whatsoever it may be, to claim revision or modification in the rates quoted by him. Representation to make correction in the tender documents on the ground of Clerical error, typographical error, etc., committed by the bidders in the Bids shall not be entertained after submission of the tenders. Cross Conditions such as "SUBJECT TO AVAILABILITY" "SUPPLIES WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED" etc., will not be entertained under any circumstances and the tenders of those who have given such conditions shall be treated as incomplete and accordingly the Tender will be rejected.

13. The drug formulation like injection, oral drugs and tablets, rates should be quoted only for the composition stated in the tender. Blood products should be supplied only after getting **HIV** and **Hepatitis-B** screening certificate. A copy of these Certificates should be sent with every consignment and every invoice.

ACCEPTANCE OF TENDER

- 1. Out of two covers submitted by each tenderer, Cover-'A' will be opened first **at 3:30 PM on 06-05-2016** in the presence of tenderer or their authorized representatives. After scrutiny of the documents and information furnished in Cover-'A' and confirmation of details stated there in a list of eligible Bidder will be shortlisted.
- 2. Cover-'B'(Price Bid) of the tenderers found eligible on the basis of scrutiny of Cover- 'A' will be opened subsequently and the date and time for opening of Cover-'B' will be intimated to the short listed tenderers. The tender evaluation committee will evaluate the tender with reference to various criteria and one of such criteria is that the rate per unit inclusive of all taxes (transportation, insurance, and any incidental charges) for determining the L1 rate (Lowest rate).
- 3. The tenderer other than L1 tenderer will be given opportunity to match L1 rate and after due confirmation, their name/s will be included in the panel. To ensure sustained supply without any interruption, the Tender Inviting Authority reserves the right to split orders for supplying the requirements among more than one bidder.
- 4. The tender inviting authority, AIIMS RAIPUR reserves the right to accept or reject any tender for any one or more of the items tendered for without assigning any reason. If L1 rate matches to equal to more than one bidder than competent authority AIIMS Raipur to issue P.O. order as recommended by the committee.
- 5. No tenderer will be allowed to withdraw their bid after opening of Price Bid.

AGREEMENT

All tenderer who are succeeded will have to execute an agreement on non-judicial stamp paper of **Rs.100**/-(stamp duty to be paid by tenderer) in favour of ALL INDIA INSTITUTE OF MEDICAL SCIENCES, RAIPUR within 15 days from the date of intimation received by them from AIIMS, Raipur that their tenders have been accepted. The form of Agreement is enclosed in tender document. The bidder shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons what so ever. All notices or communications relating to arising out of this agreement or any of the terms thereof shall be considered duly served on or given to the bidder if delivered to him or left at the premises, places of business or abode.

If the successful tenderer fails to execute the agreement and payment of security deposit within the time specified or withdraws the tender after intimation of the acceptance of the tender has been sent or owing to any other reasons, the tenderer is unable to undertake the contract, the contract will be cancelled and the Earnest Money Deposit of the tenderer shall stand forfeited. Such tenderer(s) will also be liable for all damages sustained by the Tender Inviting Authority / Ordering Authority by reasons of breach of tender conditions. Such damages shall be assessed by the Tender Inviting Authority, ALL INDIA INSTITUTE OF MEDICAL SCIENCES, RAIPUR whose decision shall be final.

PERFORMANCE SECURITY DEPOSIT

The successful tenderer must pay a performance security deposit of 10% of contracted value at the time of execution of agreement by way of DD/BG/FD in favour of AIIMS, Raipur payable at RAIPUR. The performance security deposit should remain valid for a period of sixty days beyond the date of completion of all contractual obligation of the supplier.

SUPPLY CONDITIONS AND DELIVERY PERIOD

Purchase orders along with the delivery destinations will be placed on the successful bidder at the discretion of the Ordering Authority.

- All supplies will be scheduled for the period from the date of acceptance till the completion of the tender in installments, as may be stipulated in the Purchase Order. The supplied medicines and Drugs (covered in Schedule P of Drugs & Cosmetics Act) should have a maximum potency throughout the shelf life period as prescribed in the Drugs & Cosmetics Act 1940 and rules there under. All other items of drugs and medicines should have a shelf life period of minimum 1 year (Except in that drug where self-life is recommended less than 1 year as per drug & cosmetic act 1940 but not less than 75% of expected shelf life) from the date of manufacture.
- 2. The supply should be completed within 30 days (for importer it should be 45 days) from the date of purchase order. The supplier may continue the supply of unexecuted quantity after the 30 days (for importer it should be 45 days), however liquidated damages as specified in Penalty Provision of the tender conditions, will be levied on the quantity supplied after the 30 days (for importer it should be 45 days). However, no supplies will be accepted after 3:00 PM of working days. Unloading of material will be done by supplier.
- 3. The supplier shall complete the earlier purchase order before commencing the supply of subsequent purchase orders. In case of non- execution, AIIMS Raipur reserves the right to place purchase order (partially/ fully) on alternate source at the risk and cost of the defaulting bidder.
- 4. The Bidder must submit a Test Analysis report (Certificate of Analysis) for every batch of drug along with other documents. If P.O. for single molecules is more than 50,000/- (Rupees Fifty Thousand), company has to be submit the Test Analysis report (Certificate of Analysis) from any of the recognized NABL accredited lab (for importer it should be a govt. recognized laboratories of concern Manufacturing country) at the time of supply & if P.O. for single molecules is up to 50,000/- (Rupees Fifty thousand), In-house lab testing reports are mandatory. In case of failure on part of the supplier to furnish such report, the batch of drugs will be returned back to the suppliers and the bidder is bound to replenish the same with Government approved lab test report. The Drugs and medicines supplied by the successful bidder shall be of the best quality and shall comply with the specifications, stipulations and conditions specified in the tender.
- 5. If the bidder fails to execute the supply within the stipulated time, the Tender Inviting/Ordering Authority is at liberty to make alternative arrangement for purchase of the items of drugs and medicines for which the Purchase orders have been placed, from any other sources or in the open market or from any other bidder who might have quoted higher rates, at the risk and the cost of the

supplier and in such cases the tender inviting authority /ordering authority has every right to recover the cost and impose the penalty.

- 6. It shall be the responsibility of the Bidder for any **shortages/damage** at the time of receipt. Tender inviting authority is not responsible for the stock of the drug received, for which no order is placed.
- 7. The bidder shall **take back (Reverse distribution)**, Drugs which are not utilized by the tender inviting Authority within the shelf life period based on mutual agreement.
- 8. If at any time the Bidder has, in the opinion of the Tender inviting authority/ordering authority, delayed the supply of drugs due to one or more reasons related to force **Majeure events** such as riots, mutinies, wars, fire, storm, tempest or other exceptional events, the time for supplying the drugs may be extended by the Tender inviting authority/ordering authority at its discretion for such period as may be considered reasonable. However such extension shall be considered only if a specific written request is made by the Bidder within 11 days from the occurrence of such event. The exceptional cause does not include scarcity of raw material, power cut and labour disputes.
- 9. Supply must be done by the bidder in short notice period as directed by Medical Superintendent in an emergency, if eventually so arrives.

PACKING


All primary packing containers/strips/blister should be strictly conforming to the Specification included in the relevant **pharmacopoeia**. Packing should be able to prevent damage or deterioration during transit. The labels in the case of injectable should clearly indicate whether the preparations are meant for Intravenous (IV), Intra Muscular (IM), Subcutaneous (SC), etc.

Primary packing such as strips, labels, inner carton, outer carton etc. should bear the following words

"AIIMS, Raipur (C.G.) Supply- Not for Sale"

"एम्स, रायपुर (छ. ग.) आपूर्ति- निःशुल्क वितरण हेतु"

Secondary packing such as baby shipper (small corrugated box), outer corrugated boxed are labeled as under.






Figure 3 Tablet strips/blister

QUALITY TESTING

Samples of supplies in each batch will be tested at AIIMS's Raipur empanelled lab. Payment shall only be made after receipt of 'Certificate of Analysis' from AIIMS's Raipur empanelled lab. If QA testing fails, the supplier (s) shall bear the actual expenditure incurred for the testing and the same shall be deducted from the bills or the performance security. All legal responsibility regarding quality of the product will always be with manufacturer/Importer/Distributor.

The Drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug.

PAYMENT PROVISIONS

No advance payments towards costs of drugs, medicines etc., will be made to the bidder. The verification of the bills of the supplier and supplied drugs/Hospital goods would be done by the Stores in-charge at the facilities. On receipt and after verification of the goods, it would be entered in the stock register. Payments towards the supply of drugs will be made strictly as per the rules. All bills/ Invoices should be raised in triplicate and in the case of excisable Drugs and Medicines; the bills should be drawn as per Central Excise Rules in the name of purchaser or in name of any other authority as may be designated.

If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central or State Government or by the bidder. Himself, the bidder shall be bound to inform Tender Inviting Authority immediately about such reduction in the contracted prices. Tender Inviting Authority is empowered to unilaterally effect such reduction as is necessary in rates in case the bidder fails to notify or fails to agree for such reduction of rates. In case of any enhancement in Excise Duty due to notification of the Government after the date of submission of tenders and during the tender period, the quantum of additional excise duty so levied will be allowed to be charged extra as a separate item without any change in the basic of the price structure price of the Drugs approved under the tender. For claiming the additional cost on account of the increase in Excise Duty, the bidder should produce a letter from the concerned Excise authorities for having paid additional Excise Duty on the goods supplied to Tender Inviting Authority and also must claim the same in the invoice separately. Similarly if there is any reduction in the rate of essential drug, as notified by the Govt., after the date of submission of tender, the quantum of the price to the extent of reduction of essential drug will be deducted without any change in the basic price of the price structure of the drugs approved under the tender.

PENALTIES PROVISIONS

If the supplier fails to deliver any or all of the goods or fails to perform the service within the time frame(s) incorporated in the tender, the Purchaser shall, without prejudice to other right and remedies available to the Purchaser under the tender, deduct from the quoted price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of the quoted price. Once maximum 10% of value of delayed supply is reached, Purchaser may consider termination of the tender.

If the complete supply or part thereof is received in damaged condition it shall not be accepted and shall be recorded on Deliver Challans. Such damaged material should be replaced by the supplier within 14 days from the date of noting on Delivery Challans or rejection advice issued by consignee or else subsequent to no replacement in 14 days the Performance security (SD) would be forfeited with a notice to the supplier. In case of damage only in the outer packing, the supply will be accepted only after levying penalty of 1% on the total value of the supply to that destination place. Further the Performance Security (SD) would be forfeited with a notice to the supplier.

Tender Inviting Authority will be at liberty to terminate, without assigning any reasons thereof, the contract either wholly or in part on 30 days' notice. The Bidder will not be entitled for any compensation whatsoever in respect of such termination. All litigations related to the supplier for any defaults will be done by Tender Inviting Authority and his decision will be final and binding.

BLACKLISTING PROCEDURE

- 1. Nonperformance of any tenderer conditions will disqualify a bidder to participate in the next tender.
- 2. To assess the correctness of the test results be in given by the Bidders laboratory, samples would also be taken and sent randomly to AIIMS Raipur empanelled laboratory. If there is any variation in the analytical reports furnished by empanelled laboratories, (either pass or fail) with submitted C.O.A, Bidders shall be black listed for two years besides forfeiture of security deposit, after giving due opportunity to the concerned bidders.
- 3. If it is revealed that Bidder is involved in any form of fraud and collusion with the empanelled laboratory of AIIMS, the Bidder will be blacklisted for five years. The tenderer shall also be liable for action under criminal law and matter will be informed to drugs controller for penal action against them.
- 4. AIIMS, Raipur will be at liberty to terminate the contract without assigning any reasons. The tenderer will not be entitled for any compensation whatsoever in respect of such termination.
- 5. In all matters pertaining to tender, the decision of Director, AIIMS, Raipur shall be final and binding.
- 6. In event of any dispute arising out of tender, such dispute would be subject to the jurisdiction of civil/criminal court within RAIPUR.
- 7. In case of dispute or difference arising between AIIMS RAIPUR and Bidder relating to any matter arising out of or connected with this tender agreement, such dispute or differences shall be settled in accordance with the Arbitration and Conciliation Act1996. The venue of arbitration shall be at AIIMS, RAIPUR.


ARBITRATION

If any difference arises concerning this agreement, its interpretation on payment to the made thereunder, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to Sole Arbitrator to be appointed by AIIMS, Raipur. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.

FALL CLAUSE

- 1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he offers to sell or sells the stores of identical description to any other State Government/DGS&D/Public Undertaking during the period of the contract.
- 2. If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central of State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing Authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This office will not accept any higher rates after wards.
- 3. If at any time during the period of contract, the supplier quotes the sale price of such drugs and medicines to any other State Govt. / DGS&D and Public Undertakings at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the rate contract for the supplied from the date of coming into force of such price stands correspondingly reduced as per above stipulation however reduction shall not apply to :-
- (a) Export by the supplier
- (b) For all contracts entered into prior to the date of the tender or for any backlog of pending orders.
- 4. Within six months of the commencement of the rate contract and at the rate contract period a certificate in the following forms will have to be submitted by the supplier :-

"I/We certify that the stores of description identical to the store supplied to the AIIMS Raipur, under the contract herein have not been sold by me/us to any other State Govt. /Central Govt. /DGS&D/ Public Undertaking/ Autonomous Body under government during the period of the rate contract of AIIMS Raipur under the contract / except for the quantity of under sub-clause (a) & (b) of the clause 03."

(*hereinafter* called the **'Tenderer'** which expression unless repugnant to the context shall mean and include its successors-in-interest assigns etc.) of the <u>Second Part</u>.

WHEREAS the 'Client' is desirous to engage the 'Tenderer' for providing Medicine for IPD of AIIMS, RAIPUR at Raipur on the terms and conditions stated below:

- 1. The Tenderer shall be solely responsible for any accident / medical / health related liability / compensation for the Labour deployed by it at AIIMS, Raipur site. The 'Client' shall have no liability in this regard.
- 2. Any violation of instruction / agreement or suppression of facts will attract cancellation of agreement without any reference or any notice period.
- 3. The contract can be terminated by giving one month notice on either side.
- 4. In case of non-compliance with the contract, the 'Client' reserves its right to:
 - a. Cancel / revoke the contract; and / or
 - b. Impose penalty up to 10% of the Total Annual Value of contract.
- 5. Security Deposit equal to 10% of the Annual Contract Value of validity 60 days beyond all contractual obligations (refundable without interest after two months of termination of contract) in the form of Pay Order / Demand Draft/ Bank Guarantee shall be furnished by the **'Tenderer'** at the time of signing of the Agreement.
- 6.
