 - d. DD/Pay order for tender cost Rs 1000/-
- 2. Complete Tender document duly filled should be placed in another envelope-2 marked as "Tender document"
- 3. Both the above envelope i.e. envelope-1 and envelope-2 should be placed in envelope-3 which should be superscripted with following data on it.:
- (i) Name of work
- (ii) Name of tenderer
- (iii) Last date of receipt of tender

Terms & Conditions:

1. Earnest Money Deposit: The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 1,50,000/- (Rupees One Lac Fifty Thousand only) and Tender fee of Rs. 1000/- (Rupees One Thousand only) by way of demand drafts only drawn in favour of "All India Institute of Medical Sciences, Raipur". The EMD of the successful bidder shall be kept as Security deposit and shall be returned only after completion of work. EMD for unsuccessful bidder(s) it would be returned after award of the contract. Tender received without demand drafts of EMD and tender cost shall be liable for rejection.

- **2. Rate:** Rates should be quoted in Indian Rupees (INR) and it will indicate the amount per unit of work which tenderer intend to pay to 'AIIMS Raipur'. A negative rate will be treated as the amount per unit, the tenderer intends to receive from AIIMS Raipur.
 - 3. Validity: The Tender shall be valid for 60 (Sixty) days.
- **4.** The successful tenderer shall have to pay 50% of the total accepted offer price in shape of Demand draft before commencement of work. The successful tenderer will have to submit proof of payment of royalty before lifting of earth from the campus. As soon as he lifts quantity equivalent to 50% of the offer, He have to pay balance 50% of the offer before lifting any further quantity.
- **5**. There may be increase or decrease in quantity actual available, and final payment shall be adjusted accordingly.
- **6**. He has to transport the material out of premises by using mechanical means. Loosening the dumps/ deposits, lifting, loading in truck/tipper by mechanical means to be done by him. Nothing extra is payable in this regard.
- **7.** Measurement of the quantity of earth removed from premise shall be done on the basis of actual volume of the earth in Truck or loading vehicle at the time of exit from the gate of AIIMS Raipur by authorized representative of Superintending Engineer, AIIMS Raipur.
- **8.** Royalty and any other tax as per prevailing govt. rules shall be borne by the Contractor. Any statutory permissions required to lift excavated earth and its subsequent disposal shall be responsibility of the contractor and nothing extra shall be paid on any account.
- **9.** Earth shall be lifted from the locations in order of preference communicated by the Superintending Engineer AIIMS Raipur or his authorized representative.
- **10.** Unjustified delay in lifting material shall attract a levy @1% per week, subjected to maximum10% and thereafter liable for cancellation of contract.

10. Applicable Law:

- The contract shall be governed by the laws and procedures established by Govt. of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing.
 - Any disputes are subject to exclusive jurisdiction of Competent Court and Forum in Raipur, India only.
- The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Raipur. The decision of the Arbitrator shall be final and binding on both the partied.
