**1. TENDER NOTICE**

On behalf of the Director, All India Institute of Medical Sciences, Raipur tenders are invited under two-bid system. Sealed tenders will be received till 25-03-2015 up to 03:00 PM in office of Administrative Officer for **TENDER FOR RATE CONTRACT OF DRUGS AND MEDICINES FOR IPD FOR 1 YEAR** from the date of acceptance of tender by AIIMS, RAIPUR. The tender may be extended for further period on mutually agreed terms. Demand Draft/Pay Order for Rs.5000/- (Rupees Five Thousand) (non-refundable) in favour of “Director, AIIMS, Raipur”, payable at Raipur, against cost of the tender document along with their technical bid. If firm will quote the rate for **1 to 10** items, **11 to 50** and **more than 50** items, The Earnest Money Deposit (EMD) shall be **Rs.10, 000/-** (Rupees Twenty Thousand only), **Rs.30,000/-** (Rupees Thirty Thousand only) & **Rs.1,00,000/-** (Rupees One Lac only) respectively paid in the form of Demand Draft/Pay order/FD drawn in favour of AIIMS, Raipur payable at Raipur.

Authorized dealer/distributor/wholesaler/manufacturer (Loan License, third party and contract manufacture) /importer can be eligible to participate in this tender.

**1. QUALIFICATION CRITERIA / REQUIREMENTS:**

- (a) Authorized Manufacturer/Authorized Importer /Authorized Distributer/Authorized Dealer, should have the W.H.O & GMP certificate for concern manufacturing unit of Drug products being quoted. The manufacturer should have received a valid GMP as per revised Schedule ‘M’ issued by Licensing Authority and WHO-GMP inspection certificate in line with the WHO certification scheme, on pharmaceuticals being quoted, from the regulatory authority (RA) in India. Bidder should submit a valid (at the time of bid submission date) product wise Certificate of COPP/WHO-GMP issued by Regulatory Authority of State/ CDSCO, for each item offered. Items for which FDA do not issue manufacturing license but issue repacking license, firm should have valid repacking license.
- (b) Authorized Manufacturer/ Authorized Importer /Authorized Distributer/Authorized Dealer ,should have the valid licenses for manufacturing (License issued to manufacturer) of concern items. Manufacturer should having valid License (issued by F.D.A) under the Drugs and Cosmetics Act, 1940 (including its amendments) and should comply with Schedule M (cGMP) of Drugs and Cosmetic Act. A valid document issued from regulatory authority (F.D.A) in support of this should be provided. Authorized Importer /Authorized Distributer/Authorized Dealer should also have valid licenses.

- (c) Authorized Importer / Authorized Distributer/ Authorized Dealer should have Authorization letter issued from Manufacturer of concern drug product.
  - (d) Authorized manufacturer/Authorized importer/Authorized Dealer/Authorized wholesaler/ Authorized distributor should have document of Annual turnover for concern manufacturing companies for which they are bidding. The manufacturing companies have achieved an average annual turnover of at least Rs. 06 crore during last three years i.e. 1011-1013, 1013-14 and 1014-15. The Government pharmaceutical companies are exempted from the turnover criteria.
  - (e) Manufacturer should have annual production capacity at least double the quantity of each item mentioned in the tender document. If more than one drug is quoted, production capacity shall be calculated cumulative for those particular formulations. It is mandatory to quote the tendered qty. If annual production capacity is less than the double the quoted quantity and/or the quoted/offered quantity is less, bid shall be rejected.
  - (f) Authorized manufacturer/Authorized importer/Authorized Dealer/Authorized wholesaler/ Authorized distributor should at least have 3 year market standing certificate issued to manufacturer/importer by regulatory body for each drug product quoted in the tender as a manufacturer/importer.
  - (g) Tender should not be submitted for the product/ products for which the concern manufacturer/importer company has been blacklisted on quality grounds by any Government organization.
  - (h) The bidder should give a notarized affidavit stating that "the manufacturing company/Importer has not been blacklisted for the quoted product/firm by any State Government or Central Government Organization and has not been found guilty of supplying spurious drugs in last three years and are eligible to participate in the present tender." (Notarized Affidavit per Annexure V). If the information provided in the affidavit is found to be incorrect at any stage, during and after the tender, action will be initiated as per the tender conditions apart from forfeiture of EMD and performance security deposit (if any).
3. Any future clarification and/or corrigendum(s) shall be communicated through AIIMS, Raipur website. All corrigendum(s) will always be the part of tender. **SUBMISSION OF TENDER DOCUMENT:**

4. The tenderer must submit the following documents in the sealed cover super scribed **Cover- 'A'** (all the documents have to be sealed and copies have to be self Attested and notarized in all pages).
- [a]. The Earnest Money Deposit(EMD) for **1 to 10** item shall be **Rs.10,000/-**(Rupees Twenty Thousand only), EMD for **11 to 50** items shall be Rs. **30,000/-**(Rupees Thirty thousand

only) & EMD for more than **50** items shall be **1,00,000/-** (Rupees one lakh only) paid in the form of Demand Draft/Bank guarantee/fixed deposit drawn in favour of Director, AIIMS, Raipur payable at Raipur, should be sent with tender form in Cover- 'A'. The EMD is refundable however it will not earn any interest. EMD in the form of cheque/ cash/ postal order/ e-payment will not be accepted.

The EMD amount of unsuccessful bidder will be refunded to them within 45 days of finalization of tender. In respect of successful bidder, the EMD amount will be return to after successfully submission of security deposit.

- [b].** An undertaking by the bidder that his firm/company is a manufactures/authorized dealer/ distributor/ wholesaler/importer.
- [c].** Authorization letter nominating a responsible person (Name, Address, designation contact No. and E-mail with latest photograph) of the bidder to transact the business with the Tender Inviting Authority (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).  
The firm should have availability of a responsible person on call on all working days between 09.00 Hrs. to 17.00 Hrs.
- [d].** Documentary evidence for the constitution of Manufacturing company viz. Memorandum and Articles of Association, partnership deed etc., with details of name, address, telephone no., fax no. e-mail address of Managing Director/ Partner/ Proprietor(If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [e].** The bidder should furnish self-attested notarized photocopy of manufacturing License(Own license/loan license/third party license) for the product duly approved by the Licensing authority for each and every product quoted as per specification in the tender(If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company and item). The license must have been duly renewed up to date and the items quoted shall be clearly highlighted in the license. Items for which FDA do not issue manufacturing license but issue repacking license, firm should submit valid repacking license. If revalidation of drug license has been applied, copy of application to State Drug / Licensing authority may be attached.
- [f].** Self-attested and notarized photocopy of import license (in Form 10 with Form 41), as per Rule 111A of the Drugs and Cosmetics Act 1940, if the product is imported should be furnished. The license must have been renewed up to date and the items quoted shall be clearly highlighted in the license. A copy of a valid license for the sale of Drugs imported by the firms issued by the State Licensing Authority shall be enclosed.
- [g].** A valid WHO (cGMP) (for importer COPP)/GMP as per Schedule 'M' certificate as per requirement of the Drugs and cosmetic act and rules of Govt. of India from Competent Authority(If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).



- [h].** An authorized letter issued by manufacturer/marketing Company to authorized dealer/wholesaler/distributor/importer(If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [i].** Self-attested and notarized Photo copies of certificate for Annual turnover for last **three year** to be submitted by all bidder (Authorized Manufacturer/ Authorized Importer /Authorized Distributer/ Authorized Dealer) for their concern **Manufacturer** only (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [j].** Copies of the Balance Sheet and Profit and Loss Account for the last three years i.e. 1011-11, 1011-13 and 1014-15 duly certified by the practicing Chartered Accountant. All type of bidder should submit documents of concern **manufacturer** only. (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. Company).
- [k].** Self-attested and notarized Photocopies of annual production capacity at least double the quantity of each item mentioned in the tender document (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [l].** A certificate issued by the Licensing Authority that the bidder is not currently under **conviction** under the Drugs & Cosmetics Act for manufacturing/supplying sub-standard drugs or on any other grounds. The certificate should not be more than **six month** old on the day of opening of the tender (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [M].** An undertaking by the bidder that it has not been deregistered, debarred or black listed by any govt. /autonomous institution, hospital or body in India. See para 18.
- [n].** Self-attested and notarized photocopy of Certificate of Registration for ServiceTax should be enclosed in **Annexure-III**.
- [o].** Self-attested and notarized photocopy of Certificate of last 3 years (Certificate should be enclosed with list of items) **Market Standing** as a manufacturer/direct importer for each drug quoted in the tender as manufacturer/direct importer (If bidding for more than one Manufacturing companies, they have to submit documents for each of the Mfg. company).
- [p].** Details containing the name and address of the WHO-GMP certified manufacturing premises where the items quoted are actually manufactured, its annual production capacity (formulation wise) etc. should be given in **Annexure III**.

- [q].** An undertaking by the manufacturer that they have their own **testing laboratories** and in built quality assurance facilities and shall carry out batch-wise pre-inspection of the items (covered under the drug and cosmetic act) and submit such reports along with the supplies for each batch. The drug product should have compliances as per specification (IP/BP/USP etc.), if In-house (INH) specification than provision of reference standard and testing protocol for quoted items shall be submitted.
- [r].** An undertaking by the bidder that the Expiry date should not be less than one year from the date of supply.
- [S].** An undertaking by the bidder that the requirement may develop, weekly, monthly, or annually. The successful vendor has to supply the requirements within 14 days.
- [T].** An undertaking by the bidder that requirement of the medicine from Hospital/ Institute will always be in Generic form.
- [U].** Tenderer must provide evidence of having supplied by manufacturing company to government hospital / reputed private hospital organizations in India similar nature of items
- [V].** Self-attested and notarized document of the following should be furnished in the format given in **Annexure-IIIA, B&C**
- (i) Recent List of qualified personnel employed in the Manufacturing unit along with their experience and details of their approvals.
  - (ii) List of sophisticated instruments available in the testing laboratory of Manufacturer.
  - (iii) Facilities available in Microbiological Section in the laboratory of Manufacturer.
- [w].** A declaration in the Performa given in Annexure-IV& V duly signed and notarized.
- [x].** List of Drugs and medicines to be supplied to be given in Annexure-VI.
- [y].** Details of Drugs and medicines to be supplied to be given in Annexure VII
- [y1].** The instruments such as power of attorney ,resolution of Board, Permanent Account No.(PAN)etc. authorizing the tenderer, should be enclosed in the tender(in Cover-'A')duly signed by authorized signatory of the company/firm. Such Authorized Officer of the tenderer should sign at the bottom of all the pages of the tender documents.
- [z].** The bidder should submit the copy of last of Income Tax Return of concern manufacturing/Import company only.
- [aa].** All pages of bid documents and documents enclosed with the bid document should also be seal-signed, notarized and page numbered by the bidder.

**5.OTHER DOCUMENTS TO BE ENCLOSED: [SELFATTESTEDANDNOTARIZED]**

(i). The tenderer shall submit the checklist of documents in the enclosed Performa.

**6. PRICE BID (COVER-'B')**

(a) **Price Bid (Annexure IX)** of the tenderer duly filled in giving the net rate of each items inclusive of all taxes and signed one each page by Authorized person with company seal, should be sent in separate sealed cover indicating name of the tenderer and super scribing "Price Bid" Cover-'B' hereafter called Cover-'B'.

(b) Cover-'B' shall contain the rates quoted by the tenderer only. It shall not contain any other document. No condition shall be indicated in the Price Bid. All the terms and conditions shall be indicated only in the Technical bid.

(c) The acceptable rates for supplied of drugs & medicines will be decided on the basis of L1 rates and will be communicated.

**7. (a).** The tender documents and certificates must be submitted in a separate sealed cover as **Cover-'A'** and Price Bids shall be kept in separate sealed cover as **Cover-'B'**. Both **Cover-'A'** and **Cover-'B'** shall be kept in single sealed cover on which it shall be super scribed as **"TENDER FOR RATE CONTRACT OF DRUGS AND MEDICINES FOR IPD for 1-3 YEAR"**

(b). The tender document should reach to Store Officer till date 13.03.1015 upto 03.00 PM.

(c). If the last date of submission is declared Holiday, the tenders maybe submitted on next working day upto 3.00 PM.

(d). Tenderers should also enclose Soft Copy of Price Bid in CD along with Cover-'B'.

**GENERAL CONDITIONS**

**8.** Forms in all Annexure should be filled up properly. Every correction should invariably be attested by tenderer, failing which the tender will be summarily rejected.

**9.** The tenderer may quote the rates for one or more drug and medicine of one or more manufacturing company for which authorized.

**10.** Total rates should be inclusive of all taxes as per the price bid Performa.

**11.** The rates quoted and accepted will be binding on the tenderer for stipulated period and on account any revision will be entertained till the completion of the contract period.

**11.** The details of the required drugs, medicines, etc., are shown in **Annexure-VI**. The quantity mentioned is only the tentative requirement and may increase or decrease as per the decision of Ordering Authority and/or Tender Inviting Authority. The rates quoted should not vary with the quantum of the order or the destination.

**13.** Tender has been called for in the generic names of drugs. The bidders should quote the rates for the generic products. The composition and strength of each product should be as per details given in **Annexure- VI**. Any variation, if found, will result into the rejection of the tender.

**14.** Firm should be quoted unit rate with exclusive of taxes for each of the required drugs, medicines etc., separately on door delivery basis (FOR Destination, at MS/AIIMS/RAIPUR) according to the unit ordered. Tender for the supply of drugs, medicines, etc. with cross conditions like "AT CURRENT MARKET RATES" shall not be accepted. Handling, clearing, transport charges etc., will not be paid. The delivery should be made as stipulated in the purchase order placed with successful bidders.

**15.** The price quoted by the bidders shall not, in any case exceed the controlled price, if any, fixed by the Drug Price Control Order (DPCO)/Central/State Government and the Maximum Retail Price (MRP). Tender Inviting Authority at its discretion, will exercise, the right to revise the price at any stage so as to conform to the controlled price or MRP as the case may be. This discretion will be exercised without prejudice to any other action that may be taken against the bidder at any stage (during the currency of the contract)

**16.** If in any circumstances (like breakdown of instrument or non-availability of stock etc.) the bidder is unable to supply Medicines, the same should be reported within 14 hours and Liquidated damage will be imposed for delay on supply of material.

**17.** To ensure sustained supply without any interruption, the Tender Inviting Authority reserves the right to split orders for supplying the requirements among more than one bidder.

**18.** The rates quoted and accepted will be binding on the bidder for full contract period of 1 years from the date of signing of agreement and extendable period of 6 months by mutual consent with bidder, any increase in price will not be entertained till the completion of contract. Accordingly this clause will be applicable for all orders placed during the currency of contract.

**19.** No bidder shall be allowed at any time on any ground, whatsoever it may be, to claim revision or modification in the rates quoted by him. Representation to make correction in the tender documents on the ground of Clerical error, typographical error,

etc., committed by the bidders in the Bids shall not be entertained after submission of the tenders. Cross Conditions such as "SUBJECT TO AVAILABILITY" "SUPPLIES WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED" etc., will not be entertained under any circumstances and the tenders of those who have given such conditions shall be treated as incomplete and accordingly the Tender will be rejected.

**10.** The drug formulation like injection, oral drugs and tablets, rates should be quoted only for the composition stated in the tender. Blood products should be supplied only after getting HIV and Hepatitis-B screening certificate. A copy of these Certificates should be sent with every consignment and every invoice.

**11.** The tender submitted by the bidder/manufacturer/importer which has been blacklisted by the State / Central Govt. organization, shall not be considered. submit a notarized affidavit on Indian Non judicial stamp paper of Rs. 10/- that no case is pending with the police against the Proprietor/firm/partner or the Company (Agency). Indicate any convictions in the past against the Company/firm/partner. Please also declare that proprietor/firm has never been black listed by any organization.

### **ACCEPTANCE OF TENDER**

**11.** Out of two covers submitted by each tenderer, Cover-'A' will be opened first at 03.30 PM on 13.03.2015 in the presence of tenderer or their authorized representatives. After scrutiny of the documents and information furnished in Cover-'A' and confirmation of details stated there in a list of eligible Bidder will be shortlisted.

**13.** Cover-'B'(Price Bid) of the tenderers found eligible on the basis of scrutiny of Cover-'A' will be opened subsequently and the date and time for opening of Cover-'B' will be intimated to the short listed tenderers. The tender evaluation committee will evaluate the tender with reference to various criteria and one of such criteria is that the rate per unit inclusive of all taxes (transportation, insurance, and any incidental charges) for determining the L1 rate (**Lowest rate**).

**14.** The tenderer other than L1 tenderer will be given opportunity to match L1 rate and after due confirmation, their name/s will be included in the panel. To ensure sustained supply without any interruption, the Tender Inviting Authority reserves the right to split orders for supplying the requirements among more than one bidder.

**15.** The tender inviting authority, Director AIIMS RAIPUR reserves the right to accept or reject any tender for any one or more of the items tendered for, without assigning any reason. If L1 rate matches to equal to more than one bidder than competent authority AIIMS Raipur to issue P.O. order as recommended by the committee.

**16.** No tenderer will be allowed to withdraw their bid after opening of Price Bid.

**AGREEMENT**

**17.** All tenderer who are succeeded will have to execute an agreement on non- judicial stamp paper of **Rs.100/-**(stamp duty to be paid by tenderer) in favour of ALL INDIA INSTITUTE OF MEDICAL SCIENCES, RAIPUR within 15 days from the date of intimation received by them from Director, AIIMS, Raipur that their tenders have been accepted. The form of Agreement is enclosed in tender document as ANNEXURE- I.

The bidder shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons what so ever.

All notices or communications relating to arising out of this agreement or any of the terms thereof shall be considered duly served on or given to the bidder if delivered to him or left at the premises, places of business or abode.

If the successful tenderer fails to execute the agreement and payment of security deposit within the time specified or withdraws the tender after intimation of the acceptance of the tender has been sent or owing to any other reasons, the tenderer is unable to undertake the contract, the contract will be cancelled and the Earnest Money Deposit of the tenderer shall stand forfeited. Such tenderer(s) will also be liable for all damages sustained by the Tender Inviting Authority / Ordering Authority by reasons of breach of tender conditions. Such damages shall be assessed by the Tender Inviting Authority, ALL INDIA INSTITUTE OF MEDICAL SCIENCES, RAIPUR whose decision shall be final.

**SECURITYDEPOSIT**

**18.** The successful tenderer must pay a security deposit of 10% of contracted value at the time of execution of agreement referred in Para 17 above by way of DD/BG/FD in favour of Director, AIIMS, Raipur payable at RAIPUR.

**SUPPLY CONDITIONS AND DELIVERY PERIOD**

**19. (a)** Purchase orders along with the delivery destinations will be placed on the successful bidder at the discretion of the Ordering Authority.

**(b).** All supplies will be scheduled for the period from the date of acceptance till the completion of the tender in installments, as may be stipulated in the Purchase Order. The supplied medicines and Drugs (covered in Schedule P of Drugs & Cosmetics Act) should have a maximum potency throughout the shelf life period as prescribed in the Drugs & Cosmetics Act 1940 and rules there under. All other items of drugs and medicines should have a shelf life period of minimum 1year (Except in that drug where self-life is recommended less than 1year as per drug & cosmetic act 1940 but not less than 75% of expected shelf life) from the date of manufacture.

**(c).** The supply should be should be completed within 14 days from the date of purchase order. The supplier may continue the supply of unexecuted quantity after the 14th day, however liquidated damages as specified in para 33 **(a)** and **(b)** of the tender conditions, will be levied on the quantity supplied after the 14th day. However, no supplies will be accepted after 5PM of working day from the date of issue of the purchase order & rest day and holiday. Unloading of material will be done by supplier.

**(e).**The supplier shall complete the earlier purchase order before commencing the supply of subsequent purchase orders. In case of non- execution, AIIMS Raipur reserves the right to place purchase order (partially/ fully) on alternate source at the risk and cost of the defaulting bidder.

**(f).** The Bidder must submit a Test Analysis report (Certificate of Analysis) for every batch of drug along with other documents. In case of failure on part of the supplier to furnish such report, the batch of drugs will be returned back to the suppliers and the bidder is bound to replenish the same with Government approved lab test report. The Drugs and medicines supplied by the successful bidder shall be of the best quality and shall comply with the specifications, stipulations and conditions specified in the tender.

**(g).**If the bidder fails to execute the supply within the stipulated time, the Tender Inviting/Ordering Authority is at liberty to make alternative arrangement for purchase of the items of drugs and medicines for which the Purchase orders have been placed, from any other sources or in the open market or from any other bidder who might have quoted higher rates, at the risk and the cost of the supplier and in such cases the tender inviting authority /ordering authority has every right to recover the cost and impose the penalty in **para 33**.

**(h).**It shall be the responsibility of the Bidder for any **shortages/damage** at the time of receipt. Tender inviting authority is not responsible for the stock of the drug received, for which no order is placed.

**(i).** The bidder shall **take back (Reverse distribution) drugs**, which are not utilized by the tender inviting Authority within the shelf life period based on mutual agreement.

**(j).**If at any time the Bidder has, in the opinion of the Tender inviting authority/ordering authority, delayed the supply of drugs due to one or more reasons related to force **Majeure events** such as riots, mutinies, wars, fire, storm, tempest or other exceptional events, the time for supplying the drugs may be extended by the Tender inviting authority/ordering authority at its discretion for such period as may be considered reasonable. However such extension shall be considered only if a specific written request is made by the Bidder within 11 days from the occurrence of such event. The exceptional cause does not include scarcity of raw material, power cut and labour disputes.

## **PACKING**

30. All primary packing containers/strips/blister should be strictly conforming to the Specification included in the relevant **pharmacopoeia**. Packing should be able to prevent damage or deterioration during transit. The labels in the case of injectable should clearly indicate whether the preparations are meant for Intravenous (IV), Intra Muscular (IM), Subcutaneous (SC), etc.

Tablets and Capsules should be supplied in Strips or Blisters or as mentioned in the list of items for tender. The strip, etc, should bear the following logograms and the words “**AIIMS, Raipur (C.G.) Supply- Not for Sale निःशुल्क वितरण हेतु QC – Passed**” overprinted. Name of drug should be printed in English and Hindi languages and should be

The name of the drug shall be mentioned in Hindi and English and should be legible and be printed more prominently. **A uniform colour theme and artwork will be necessary.** Apart from this “**For AIIMS, Raipur (C.G.) – Not for Sale निःशुल्क वितरण हेतु QC – Passed**” along with logo of AIIMS, Raipur will be printed on each strip/label of the bottle. The storage directions should be clear, legible and preferably with yellow highlighted background.

1. Bids for the supply for Drugs and medicines etc., shall be considered only if the

Bidder gives undertaking in his Bid that the supply will be prepared and packed with the logogram printed on the strips of tablets and capsules and labels of bottles, ampoules and vials etc., as per the design mentioned above.

2. All tablets and capsules have to be supplied in standard packing in aluminum strip or blisters with aluminium foil back with printed logogram and shall also conform to schedule P1 of the Drugs & Cosmetics Act & Rules wherever it applies. Affixing of stickers and rubber stamps shall not be accepted.
3. Labels of Vials, Ampoules and Bottles containing the items Bided for should also carry the logogram.
4. Failure to supply Drugs etc., with the logogram will be treated as breach of the terms of agreement and liquidated damages will be deducted from bills payable as per conditions in Clause 19.2 Bidders who are not willing to agree to conditions above will be summarily rejected.
5. In case of imported drugs affixing rubber stamp on the original label is allowed with indelible ink on inner most and outer packing.

### **QUALITY TESTING**

31.(a).Samples of supplies in each batch will be tested at AIIMS's Raipur empanelled lab. Payment shall only be made after receipt of 'Certificate of Analysis' from AIIMS's Raipur empanelled lab. If QA testing fails, the supplier (s) shall bear the actual expenditure incurred for the testing and the same shall be deducted from the bills or the performance security. All legal responsibility regarding quality of the product will always be with manufacturer.

(b).The Drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug.

### **PAYMENT PROVISIONS**

**31. (a).**No advance payments towards costs of drugs, medicines etc., will be made to the bidder.

**(b).** The verification of the bills of the supplier and supplied drugs/Hospital goods would be done by the Stores in-charge at the facilities. On receipt and after verification of the goods, it would be entered in the stock register. Payments towards the supply of drugs will be made strictly as per the rules.

**(c).** All bills/ Invoices should be raised in triplicate and in the case of excisable Drugs and Medicines; the bills should be drawn as per Central Excise Rules in the name of purchaser or in name of any other authority as may be designated.

**(d).** If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central or State Government or by the bidder

himself, the bidder shall be bound to inform Tender Inviting Authority immediately about such reduction in the contracted prices. Tender Inviting Authority is empowered to unilaterally effect such reduction as is necessary in rates in case the bidder fails to notify or fails to agree for such reduction of rates.

**(e).** In case of any enhancement in Excise Duty due to notification of the Government after the date of submission of tenders and during the tender period, the quantum of additional excise duty so levied will be allowed to be charged extra as a separate item without any change in the basic of the price structure price of the Drugs approved under the tender. For claiming the additional cost on account of the increase in Excise Duty, the bidder should produce a letter from the concerned Excise authorities for having paid additional Excise Duty on the goods supplied to Tender Inviting Authority and also must claim the same in the invoice separately. Similarly if there is any reduction in the rate of essential drug, as notified by the Govt., after the date of submission of tender, the quantum of the price to the extent of reduction of essential drug will be deducted without any change in the basic price of the price structure of the drugs approved under the tender.

### **PENALTIES PROVISIONS**

**33. (a).** If the supplier fails to deliver any or all of the goods or fails to perform the service within the time frame(s) incorporated in the tender, the Purchaser shall, without prejudice to other right and remedies available to the Purchaser under the tender, deduct from the quoted price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of the quoted price. Once maximum 10% of value of delayed supply is reached, Purchaser may consider termination of the tender.

**(b).** If the complete supply or part thereof is received in damaged condition it shall not be accepted and shall be recorded on Deliver Challans. Such damaged material should be replaced by the supplier within 14 days from the date of noting on Delivery Challans or rejection advice issued by consignee or else subsequent to no replacement in 14 days the Performance security (SD) would be forfeited with a notice to the supplier. In case of damage only in the outer packing, the supply will be accepted only after levying penalty of 1% on the total value of the supply to that destination place. Further the Performance security (SD) would be forfeited with a notice to the supplier.

**(d).** Tender Inviting Authority will be at liberty to terminate, without assigning any reasons thereof, the contract either wholly or in part on 30 days' notice. The Bidder will not be entitled for any compensation whatsoever in respect of such termination. All litigations related to the supplier for any defaults will be done by Tender Inviting Authority and his decision will be final and binding

**BLACKLISTINGPROCEDURE**

**34.(a).**Non performance of any tenderer conditions will disqualify a bidder to participate in the next tender.

**(b).** To assess the correctness of the test results be in given by the Bidders laboratory, samples would also be taken and sent randomly to AIIMS Raipur empanelled laboratory. If there is any variation in the analytical reports furnished by empanelled laboratories, (either pass or fail) with submitted C.O.A, Bidders shall be black listed for two years besides forfeiture of security deposit, after giving due opportunity to the concerned bidders.

**35.** If it is revealed that Bidder is involved in any form of fraud and collusion with the empanelled laboratory of AIIMS, the Bidder will be blacklisted for five years. The tenderer shall also be liable for action under criminal law and matter will be informed to drugs controller for penal action against them.

**36.** The Director, AIIMS, Raipur will be at liberty to terminate the contract without assigning any reasons. The tenderer will not be entitled for any compensation whatsoever in respect of such termination.

**37.** In all matters pertaining to tender, the decision of Director/AIIMS/Raipur shall be final and binding.

**38.** In event of any dispute arising out of tender, such dispute would be subject to the jurisdiction of civil court within RAIPUR.

39. In case of dispute or difference arising between AIIMS RAIPUR and Bidder relating to any matter arising out of or connected with this tender agreement, such dispute or differences shall be settled in accordance with the Arbitration and Conciliation Act1996.The venue of arbitration shall be RAIPUR.

**Arbitration:**

**40.** If any difference arises concerning this agreement, its interpretation on payment to the made thereunder, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to Sole Arbitrator to be appointed by the Director, AIIMS, Raipur. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.



**Fall Clause**

1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he offers to sell or sells the stores of identical description to any other State Government/DGS&D/Public Undertaking during the period of the contract.
2. If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central or State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing Authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This office will not accept any higher rates after wards.
3. If at any time during the period of contract, the supplier quotes the sale price of such Equipments or sells such Equipments to any other State Govt. / DGS&D and Public Undertakings at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the rate contract for the Equipments supplied from the date of coming into force of such price stands correspondingly reduced as per above stipulation however reduction shall not apply to :-
  - (a) Export by the supplier
  - (b) For all contracts entered into prior to the date of the tender or for any backlog of pending orders.
